The Extraordinary General Shareholders' Meeting of the Bank was held on November 3, 2016, Thursday, at 10:00a.m., at the address of Levent, Nispetiye Mahallesi, Aytar Caddesi No:2 34340 Beşiktaş-İSTANBUL and it is resolved that:

Since the external audit agreement signed with DRT Bağımsız Denetim ve Serbest Muhasebeci Mali Müşavirlik A.Ş. (Deloitte Touche) will expire by the end of the 2016 accounting period, according to Article 26 of the "Independent Audit By-Law" issued by the Public Oversight, Accounting and Auditing Standards Authority (POA), the Bank is required to apply external auditor rotation procedure.

Accordingly, Akis Bağımsız Denetim ve Serbest Muhasebeci Mali Müşavirlik A.Ş. (KPMG) be selected as the auditor of the Bank and the group for the 2017 accounting period, in accordance with the Turkish Commercial Code.

The meeting minutes and the list of participants are attached hereto. (The meeting minutes is in Turkish and English, whereas the list of participants is in Turkish.

In contradiction between the Turkish and English versions of this public disclosure, the Turkish version shall prevail.

We declare that our above statements are in conformity with the principles included in the Board's Communiqué, Serial II Nr.15.1, that it exactly reflects the information we received; that the information complies with our records, books and documents; that we did our best to obtain the correct and complete information relative to this subject and that we are responsible for the declarations made in this regard.

MINUTES OF THE EXTRAORDINARY GENERAL SHAREHOLDERS' MEETING OF TÜRKİYE GARANTI BANKASI A.Ş. HELD ON NOVEMBER 3RD, 2016

The Extraordinary General Shareholders' Meeting of Türkiye Garanti Bankası A.Ş. was held on November 3rd 2016 at 10.00 a.m. at the address of Levent, Nispetiye Mahallesi, Aytar Caddesi No: 2 Beşiktaş - Istanbul, under the supervision of the representatives of the Ministry of Customs and Trade Metin YONEY and Feyyaz BAL, authorized by The Republic of Turkey, Istanbul Governorship Provincial Office for Trade's letter dated 02.11.2016 and numbered 00019868072.

The invitation to the meeting, including the agenda, was announced three weeks prior to the meeting date calculated by excluding the announcement and meeting dates in accordance with the relevant legislation and the Articles of Association, in the Turkish Trade Registry Gazettes dated October 10, 2016, numbered 9172 and, in the Posta and Sözcü Newspapers dated October 11, 2016, on the Bank's websites at www.garanti.com.tr and www.garantiinvestorrelations.com, on the Public Disclosure Platform and on the Electronic General Assembly System and e-Company Information Portal of the Central Registry Agency.

Pursuant to paragraphs 5 and 6 of article 1527 of the Turkish Commercial Code, the Bank's preparations for its Electronic General Shareholders' Meeting were carried out in compliance with the regulations, and the General Shareholders' Meeting started simultaneously on physical and electronic platforms. Ömer ÇİRKİN was assigned the task of handling the Electronic General Assembly System.

Müjde Şehsuvaroğlu, the representative of the Bank's auditor and group auditor DRT Bağımsız Denetim ve Serbest Muhasebeci Mali Müşavirlik A.Ş was present at the meeting.

Upon examination of the Attendance List, it was concluded that out of the 420,000,000,000 shares equivalent to the Bank's issued capital of TRY 4,200,000,000; a total of shares corresponding to TRY 3.411.965.944,99 were present in the meeting with shares corresponding to TRY 1.883,93 being represented in person and shares corresponding to TRY 3.411.964.061,06 being represented by proxy whereas shares corresponding to TRY 1.316.156.904,50 were represented by the representatives of the depositors. Therefore the minimum meeting quorum set forth in the legislation and the Articles of Association was met.

The Meeting was opened by Board Member/CEO Ali Fuat ERBİL in accordance with Article 34 of the Bank's Articles of Association and the Internal Directive for the Working Methods and Principles of the General Assembly.

1-) In order to establish the Board of Presidency, the proposal given by Ceylan KARA, the representative of one of our Bank's shareholders, Banco Bilboa Vizcaya Argentaria S.A., was read and voted.

Upon the proposal that was submitted, with dissenting votes of shares corresponding to TRY 5 versus affirmative votes of shares corresponding to TRY 3.411.965.939,99; it was resolved that Avni Aydın DÜREN be elected as the President of the Meeting.

The President of the meeting assigned Hisar Ege TOPRAK ERDOGAN and Ceylan KARA as vote collecting clerks and Gizem Duygu SELVİ as the secretary for writing the minutes of the meeting.

2-) Since the external audit agreement signed with DRT Bağımsız Denetim ve Serbest Muhasebeci Mali Müşavirlik A.Ş. (Deloitte Touche) will expire by the end of the 2016 accounting period, according to Article 26 of the "Independent Audit By-Law" issued by the Public Oversight, Accounting and Auditing Standards Authority (POA), the Bank is required to apply external auditor rotation procedure.

Accordingly, the selection of Akis Bağımsız Denetim ve Serbest Muhasebeci Mali Müşavirlik A.Ş. (KPMG) (currently located at the address of Kavacık Rüzgarlı Bahçe Mah. Kavak Sok No:29 34805 Beykoz/İSTANBUL with mersis no. 0589-0269-9400-0013, trade registry no. 480474 registered in Istanbul Trade Registry and tax no. 5890269940 registered in Bogazici Corporates Tax Office,) as the auditor and group auditor for 2017 accounting period as per the Turkish Commercial Code, was submitted for the approval of the General Assembly.

As a result of the voting, the selection of KPMG as the auditor and group auditor for 2017 accounting period was accepted by the majority of the votes, with dissenting votes of shares corresponding to TRY 13.393.979 versus affirmative votes of shares corresponding to TRY 3.398.571.965,99.

President of the Meeting has asked to the shareholders whether they would like to take the floor or not. Shareholder Ali İhsan Gürcan has explained his claims regarding qualifications which should exist in an auditor and explained his wishes regarding Capital Markets Board to support the minority shareholders. Another Shareholder Hamza İnan also declared his opinion regarding the independent auditor.

As there were no other items to be discussed in the agenda, the President of the Meeting declared the end of the meeting after thanking the General Assembly.
