On Jan. 14, 2016 Simple Interest Rate of 122-day Bank Bonds has been determined as 10.77080%, Compound Interest Rate as 11.16157% and Selling Price as 96.525 TL and Simple Interest Rate of 370-day Discounted Bonds has been determined as 11.55484%, Compound Interest Rate as 11.54603% and Selling Price as 89.515 TL.
